RENAULT SPORT ENTHUSIAST DAYS INTERNAL REGULATIONS

1 - Applications

The capacity for registrations will vary according to the Renault Sport Enthusiast Day. Participants are invited to refer to the documentation relative to each of the Renault Sport Enthusiast Days to view the number of places available. Registration requests are processed in the order in which they are received.

Applications will only be taken into account if they are accompanied by the correct documentation, and a payment corresponding to the registration fees, as well as the document "Statement of Responsibility/Liability" which is duly completed for the days on the circuit (track days, driving schools, Renault Sport discovery days, special days: Women Only, Racing, etc.). Any application which does not meet these conditions will be returned to the applicant. Application forms for any non-driver passengers under the age of minority must be accompanied by signed authorization from the parent or guardian for the minor concerned (see document Parental Consent).

Payments can be made by internet, bank transfer or cheque.

The Organizer reserves the right to refuse at his discretion any application for registration received from an individual not having observed these internal regulations or having driven in a fashion which is dangerous or contrary to the instructions given in the course of a previous Renault Sport Enthusiast Day.

Applications for registration arriving after the cut-off date specified in the documentation relative to Renault Sport Enthusiast Day may only be considered if they meet all the requirements of the previous paragraph, at the discretion of the Organizer and on condition that it is reasonably possible for the Organizer to process the application despite its lateness.

Cheques attached to the registration application will be banked on the closing date for registrations, fifteen business days prior to the date of the Renault Sport Enthusiast Day in question.

2 - Cancellation: 3 POSSIBILITIES

Participants have the opportunity to cancel their registration by informing the Organizer by post or by email at journees.passion@renault.com prior to the closing date for registrations specified in the documentation relating to Renault Sport Enthusiast Days. For payments made by internet or bank transfer, a complete set of bank details must be sent to us in order that we can perform a refund. The cheque attached to the registration application will be returned to the address featuring on the application or destroyed if agreed by the customer.

The Organizer reserves the right to cancel the Renault Sport Enthusiast Day concerned at the end of the registration period. The Organizer will then inform the Participants as soon as possible and no later than the date stated in the documentation relative to the Renault Sport Enthusiast Day.

Furthermore, the Organizer reserves the right to cancel the Renault Sport Enthusiast Day at any moment in case of force majeure. In case of cancellation, the Organizer will refund to individuals duly registered the sum of their registration fees. For payments made by internet or bank transfer, a complete set of bank details must be sent to us in order that we can perform a refund. The cheque attached to the registration application will be returned to the address featuring on the application or destroyed if agreed by the customer.

3 - Vehicles

Vehicles accepted: vehicles from the Renault and Renault Sport brands and, subject to prior agreement by Renault Sport Technologies, vehicles from other Brands.

As the Renault Sport Enthusiast Days involve the use of Participants' vehicles (track days, owners rally, etc.), these vehicles must present the following characteristics:

- Vehicles must comply with the requirements of the current vehicle legislation, particularly in terms of noise.
- Vehicles must be in perfect operational condition.
- Vehicles must at all times be equipped with homologated road tyres in good condition (competition, slick or wet tyres are prohibited).
- Vehicles must have their administrative documents (vehicle registration document in the name of the participant or accompanied by a statement from the owner giving permission for the vehicle to be used by the Participant within the context of the Renault Sport Enthusiast Day).
- Vehicles must be insured.
- Vehicles must comply with regulations in respect of periodic technical inspections.

The Organizer reserves the right to inspect or to have inspected the respect of these conditions at any point during Renault Sport Enthusiast Days. It may in particular request the presentation of the registration document in the name of the Participant or the statement by the owner giving permission for the use of the vehicle within the context of the Renault Sport Enthusiast Days in question, valid technical inspection and insurance certificates.

Any participant whose vehicle does not respond to all the requirements above, or who refuses to submit to inspection by the Organizer, may be refused or excluded immediately and at any moment, without this necessitating a full or partial reimbursement of the registration fee.

The presence of a vehicle on the track does not, of itself, constitute acknowledgement, implicit or otherwise, by the organizers of its compliance with the conditions defined in this article.

Renault Sport Technologies will organize "Special" Days as follow:

Racing Day: On circuits dedicated to saloon or single-seater competition cars.

During these days, the use of competition tyres will be allowed. Vehicles must comply with standards for safety and noise in place at these circuits.

Any Participant at these days dedicated to saloon and/or single-seater cars must ensure the presence of front and rear towing rings and roll cages in their vehicles and wear fire-retardant clothing: gloves, overalls, boots. Furthermore, it is obligatory to wear a full-face helmet for open-top single-seater or roadster type cars.

Women-Only Days: On circuits, dedicated exclusively to women with their own vehicle or a vehicle provided by Renault Sport.

"Trip" Days: on the public highway, driving days for participants driving their own vehicle. These days are reserved for vehicles in full compliance with vehicle legislation and the Highway Code.

Visit days: discover the Renault Heritage workshops. Tour of the industrial plant at Flins led by a qualified guide.

Participants are subject to specific rules for each day which will be outlined during the briefing.

4 – Driving license

Any Participant in a Renault Sport Enthusiast Day during which he/she has cause to drive a production vehicle must possess a valid Category B driving license (except where the documentation relative to the Renault Sport Enthusiast Day in question expressly specifies that this condition is not required). The Organizer reserves the right to request its presentation at any time.

In failing to produce his/her driving license, the Participant may be refused or excluded immediately and at any time, without this necessitating a full or partial reimbursement of the registration fee.

5 - Equipment

When driving on the circuit with the Participant's vehicles, the drivers and passengers must wear a helmet of the correct size and which is correctly fitted. This must be a full-face type helmet when driving a roadster or spider type car. It is recommended that participants wear comfortable sports clothes. There should be no unsecured equipment inside the cabin.

6 - Safety

The Renault Sport Enthusiast Days are and shall remain friendly events during which Participants share their enthusiasm in total safety. It is in no way a competitive event.

The following rules must be strictly observed by all participants during Renault Sport Enthusiast Days involving the use of vehicles:

- Participation in the briefing is mandatory for all participants,
- Participants must respect the instructions of the Organizer at all times,
- Any behaviour which is dangerous or which contravenes the instructions may result in immediate exclusion from the Renault Sport Enthusiast Day, without this necessitating a full or partial reimbursement of the registration fee. The Organizer reserves the right to refuse at his discretion any application for registration received from an individual not having observed these internal regulations or having driven in a fashion which is dangerous or contrary to the instructions given during a previous Renault Sport Enthusiast Day.

On the public highway:

- Strict compliance with the Highway Code.

On circuits:

- Wearing of seatbelt mandatory
- Number of people in the vehicle limited to 2 (two),
- Strict respect of flags
- Overtaking is only permitted on straights, respecting the instructions given during the briefing at the start of the day
- The overtaken vehicle must allow the overtaking vehicle to overtake, which in turn must wait for the overtaken vehicle to give way before overtaking.
- Respect a distance of 40 meters between vehicles,
- It is prohibited to drive against the flow of traffic or to reverse,
- It is forbidden to stop on the track, or in the braking or accelerating lanes,
- Front windows must be closed
- Speed must be reduced in the pits and paddocks (30kph).

The organizer may interrupt a Renault Sport Enthusiast Day momentarily or definitively if required to do so by safety conditions, without this necessitating the reimbursement of all or part of the registration fee.

7 - Responsibility

Participants are aware of the risks presented by sports track driving, including in conditions of optimum safety. The Organizer, its partners or their representatives cannot be held responsible in case of physical or material damage which may arise during Renault Sport Enthusiast Days.

Participants consequently waive any right to the liability of the Organizer, its partners, their employees and insurers in case of physical or material damage which may arise during Renault Sport Enthusiast Days, in their own name as in the name of their beneficiaries or any persons subrogated.

In respect of this, the participant undertakes to sign by simple request of the Organizer a discharge of responsibility, a template for which can be found at www.renault-sport.com.

8 - Insurance

Participants are informed that driving on the circuit requires subscription to specific insurance. The Participant must verify that his/her insurance policy covers this type of activity prior to each access to the track.

It is the participant's obligation to subscribe to at least one insurance policy (Third Party Vehicle Cover) guaranteeing the driver's legal responsibility can be honoured in the event of damages incurred by a third party resulting from damages to persons or property in which the vehicle is implemented This insurance contract must be held with a reputable insurance company, approved to practice its activities as an insurer against accidents resulting from the use of automotive vehicles. The participant undertakes to inform his/her insurer of the specific and exceptional use of the vehicle within the context of a Renault Sport Enthusiast Day on a circuit either closed or not and to confirm the validity of his/her insurance for this use.

The aim of the subscription to this policy is to satisfy the legal obligation prescribed in article L.211-1 of the French Insurance Code.

The participant must be able to provide the Organizer with a statement of insurance certifying his/her subscription to the guarantee described above certificate when asked to do so by the Organizer.

Moreover, it is the decision of Participant to subscribe or not to insurance which covers any damages of any sort occasioned upon the vehicle of which he/she is the owner. Any damage to the vehicle, even accidental, not covered by an insurance policy shall be the sole responsibility of the owner of the vehicle.

Furthermore, it is the decision of Participant to subscribe or not to insurance which covers the driver fall all risks of physical injury.

On the other hand, it is the Participant's obligation to subscribe to Third Party insurance covering any physical or material damages which he/she may cause during a Renault Sport Enthusiast Day. He/she must produce proof of this when required to do so by the Organizer.

Finally, the Participant absolves RENAULT of any liability in case of failure by his/her insurer or non-subscription to one of the policies above.

9 - Caution

For Renault Sport Enthusiast Days which take place on circuits (driving schools or track days), it may be expressly required that a damage deposit cheque may be paid to the Organizer by each driver, before any entry to the track. This is also mentioned in the documents relative to the Renault Sport Enthusiast Days concerned and the following rules apply in the event of damage caused by a Participant to other vehicles and/or installations of the driving school or circuit.

- The value of damages as assessed by the driving school or circuit is greater than or equal to the value of the damage deposit, the entire damage deposit will be retained by the driving school or circuit. No additional sum shall be sought from the Participant
- The value of damages as evaluated by the driving school or circuit is less than or equal to the value of the damage deposit, the Participant will be expected to pay only the value of the damage.

10 - Access to the sites

Non-compliance with this rule may result in exclusion from the Day.

(Regulation 4/4)

1. Purpose

2. Offer validity

Our offers are subject to availability at the time of registering.

The Beneficiary of a Gift Voucher can attend their day from the date on which they registered and made payment until the end of the calendar year. Renault Sport Technologies reserves the right to refuse to honour an order placed by a customer who has failed to make full or partial payment on a previous order, or with whom a dispute over payment is pending.

Renault Sport Technologies accepts the following payment methods:

- Online payment by credit card. All French credit cards are accepted, as are Eurocard/Mastercard and international Visa cards; payments are made in a secure payment area. The customer enters their credit card number and expiry date in a secure payment area in which data is encrypted. As a result, bank details provided are secure and cannot be accessed by an unauthorized third party.
